婆那加佔婆塔:

是古代占婆王國的寺廟，建於西元 7-12 世紀間，共有三層，其中，最高的一層包含有兩排的塔，其主塔高 25 米。經過一千多年之後，僅剩的 4 座建築較完整地保留了下來，如今不僅僅遊客會來參觀，很多當地人也會前來參拜和祈禱。在塔群旁邊還有一個小型展示廳，展出了象神 Ganesh 等雕塑。從位於小山上的婆那加占婆塔往下看，能看到芽莊碧藍的海港。
