是早期占婆王國的首都因陀羅補羅(Indrapura 又譯「林邑浦」)即設在會安一帶 因此附近甚為 繁榮。16世紀時 這座位於秋盆江江口的城市為 國際貿易興盛的港埠 當時從中國來的華人 與日 本人、荷蘭人、及印度人等都在此進行貿易。直到 19世紀秋盆江逐漸淤塞後 港口功能被峴港取代 才逐漸沒落。會安是一座被分割的城鎮 以「日本 橋」(來遠橋)為界 一邊為華人區 另一邊為日 本人落戶的地方。這座橋是由日本人所建造 且以 獨特式的廊橋結構而聞名 橋邊也蓋了一座佛塔。
